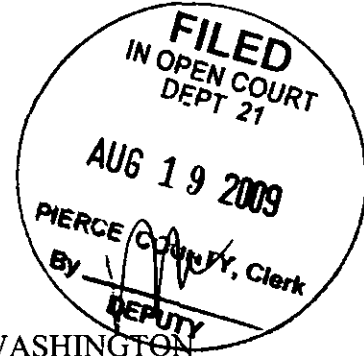

**ORDER ON RECEIVER'S EX PARTE MOTION TO REVISE CASE MANAGEMENT ORDER**

1. The Proof of Claim form shall be changed to leave the Claims Bar Date blank, except that the date of December 12, 2009 shall be used for the published Notice. The revised form Proof of Claim is attached hereto as Exhibit A.

2. The Notice of Pendency of Receivership Proceeding, Claims Bar Date Notice, and Proof of Claim Form shall not be required to be published in the Seattle Times.

3. The first three sentences of Paragraph 1 of the Case Management Order shall be changed to read as follows:

The requirement to give Notice of the Pendency of the Receivership Case and establishment of a Claims Bar Date is hereby extended to December 12, 2009 or to such later date as may be ordered by the Court. The Court approves the revised form of Notice and Proof of Claim form as identified in the attached Exhibit A. Upon reasonable identification of potential claimants, the Receiver shall cause to have the Notice, Claims Bar Date, and Proof of Claim published in the Tacoma News Tribune once a week for three consecutive weeks.

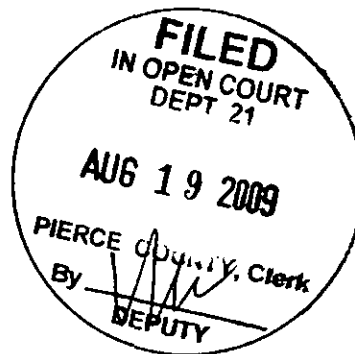
4. All other provisions of the Case Management Order remain in effect, subject to further modification by the Court.
